

## 2025 Raffle Rules

- 1. Raffle tickets shall not be sold to persons under the age of 18.
- 2. Raffle tickets to be sold only in Alberta.
- **3.** Raffle tickets will be available for purchase in-person and on our website, by mail, payable by cash, cheque or square reader. Tickets will be advertised on the website for purchase for people 18 years and older. All tickets sold on our website will be mailed to the purchaser. We use Ecwid for our online store sales and they are PCI DSS certified with some of the highest international standard for secure data exchanges for online stores and payment systems.
- **4.** The raffle prizes are as follows: **1.** 2025 Polaris RZR XP1000 Sport with poly roof and 4500 lb winch. Retail: \$27648.98. **2.** 2 E-bikes Cannondale Adventure Neo Allroad. - 5. Ticket sellers shall advise buyers not to write the name of person or persons under 18 years of age on ticket.
- **6.** The draw will be held on October 1, 2025 at the Quad Squad Office located at 8342-19 Ave., Coleman, AB and is open to the public. The sales cut-off for the draw will be September 24, 2025.
- 7. There shall be no restrictions on members of the organization buying tickets.
- **8.** There shall be 13,500 three for \$20 tickets printed and 300 one for \$10 tickets printed. There shall be a minimum of 10,000 tickets sold to cover the organizations costs or an application for extension will be made to AGLC, and with ALGC approval a revised raffle draw date shall be established. The date for determination and application for extension will be August 30<sup>th</sup>, 2025.
- **9.** There shall be no refunds on ticket sales.
- **10.** Notice advising ticket purchasers, in the event a winning ticket stub has more than one name on it, the licensed not for profit association shall award the prize to only one of the individuals identified on the ticket, and that the licensed not for profit association and the AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
- 11. Winning tickets will be returned to the draw barrel for all subsequent draws.
